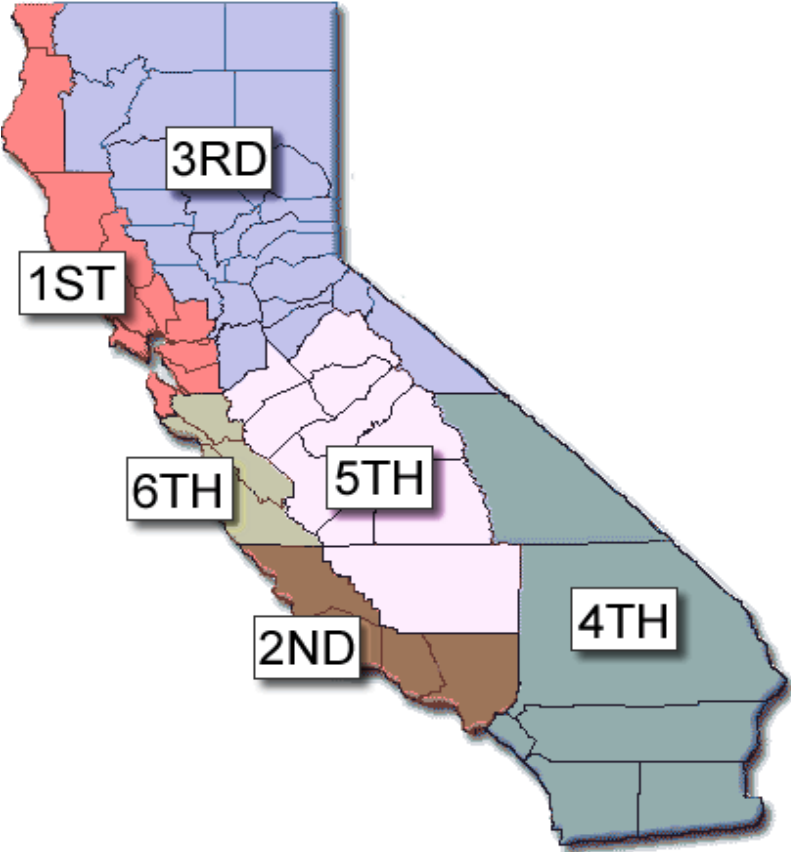

Upon your initial login, you will set your permanent/private password to anything of your choosing, including using the same password you use for other projects' eClaims.
